Your Right to Cancel

Payment Arrangements

The funeral account will be submitted to the applicant as soon as practical after the funeral service. It is due for payment in full within thirty days of the date on the account, unless otherwise agreed by us in writing.

If you fail to pay us in full on the due date, we may charge you interest:

- at a rate of 4% above our bank's Base Rate from time to time in force;
- calculated (on a daily basis) from the date of our account until payment;
- compounded on the first day of each month; and
- Before and after any Judgment (unless a Court orders otherwise).

We will recover the cost of taking legal action to make you pay.
